# **Kimpton Parish Council**

# **Action Plan**

Kimpton Parish Council (KPC) constantly strives to work on behalf of the community to enhance the quality of life for residents, to maintain a strong community spirit and to uphold the village identity. KPC will be a strong voice for residents and local businesses on matters that are important to them.

KPC will provide effective, efficient and accountable local government for the parish, enabling residents to be involved in the life of the community and its future development. Councillors are keen to receive ideas and suggestions from parishioners on areas of interest or concerns and where it is felt that the parish council may assist.

This action plan was informed by:

- Kimpton Parish Plan 2012
- Kimpton Housing Survey 2019
- The views of Parish Councillors
- Community representation at meetings
- Community engagement on social media

The Action Plan will be reviewed annually following confirmation of the budget for the following financial year.

# A) Aspirations of Kimpton Parish Council (what the council wants the Parish to be)

- 1. Ensure Kimpton Parish is a place where all residents can enjoy a healthy lifestyle.
- 2. Support non-profit making public amenities that provide valued service to the community through grants and practical support.
- 3. Protect the surrounding countryside from inappropriate development.
- 4. Protect the village appearance from poor planning.
- 5. Ensure Kimpton Parish is a place where its occupants feel safe in their home and surroundings.
- 6. Work with the Police and HCC to improve road safety and parking.
- 7. Have a strong local economy and job opportunities.
- 8. Increase public involvement in the community by ensuring the parish council is open, transparent and accountable to residents.

# B) Objectives within the Financial Year 2022/23

- 9. New Councillor Training to be offered and specialist training for membership of Staffing Committee and working Parties.
- 10. Refurbish the interior of the Recreation Ground pavilion.
- 11. Install outdoor fitness equipment at Recreation Ground.
- 12. Generate a plan for additional recreational/sporting facilities at Parkfield Sports Ground.
- 13. Regularly maintain Kimpton PC website and ensure that it complies with GDPR requirements.
- 14. Continue to have a presence on social media platforms to help increase communication with the community.
- 15. Complete phase 2 of the hedgerow planting scheme for Parkfield Sports Ground.
- 16. Encourage the community to get involved with climate change initiatives.
- 17. Organise a Christmas Market 2022 and review winter lighting schemes.

- 18. Review the condition of the access roads to Parkfield Sports Ground and Recreation Ground and instigate remedial works.
- 19. Review the condition of the roadway around The Green and instigate remedial works.
- 20. Support Kimpton Primary School and Kimpton Pre-School to ensure high quality education establishments are serving the children of the parish.

Project plans will be devised for the above short-term objectives which will inform the communications and engagement strategy.

# C) Medium Term Objectives (12 -24 months)

- 21. Review the maintenance regime of the highway gullies.
- 22. Increase the amount of affordable housing for use by local people and key workers.
- 23. Lobby for constraint of negative impact from any expansion of Luton Airport.
- 24. Lobby for a safe cycle route from Kimpton to Harpenden.
- 25. Ensure that the parish continues to be served by a Doctor's Surgery and health services.
- 26. Lobby for the implementation of a 20mph speed limit in Kimpton.
- 27. Use of s106 contributions to mitigate the effects of local development.

#### D) Long Term Objectives (24 months or greater)

- 28. Encourage more employment in the local area.
- 29. Encourage more volunteers to get involved with community fund raising or projects.
