#### **Kimpton Surgery**

- a) To review the proposed changes in GP provision in Kimpton  
Dr Pathmanathan, Bridge Cottage Surgery attended a public meeting, attended by approximately 50 residents, held at 6.30pm prior to the council meeting. A summary outlining the reasons for the preferred option of closing the Kimpton Branch Surgery was given and the alternatives that have been explored. The reasons for closure included safety concerns of loan working and the requirement from new practitioners to have two clinicians on site at any one time, the lack of disability access at Kimpton Surgery and travel time for clinicians reducing appointment availability. Details of unsuccessful property grant applications, that would have improved the physical features of the branch surgery, were given. 700 Kimpton patients (out of 16,000 patients in the practice) will be affected of which 300 only use Kimpton surgery. The other 400 patients, prior to the pandemic, use both the Welwyn and Kimpton surgeries for their appointments. Residents raised questions about the options that have been explored, the financial situation relating to the property and concern for the vulnerable in the village being able to access GPs. Many expressed their strong disappointment at the closure and worry that health care would be reduced for patients. Bridge Cottage Surgery reassured the meeting that home visits would continue. It was mentioned that the NHS in general is under severe strain and that the Government is looking at Integrated Care Systems involving local authorities and NHS working together.
- b) To consider making an application to North Herts Council for registration of 9 High Street, Bridge Cottage Surgery as an Asset of Community Value  
**Resolved**, proposed Cllr D Reavell, seconded Cllr S O'Brien to make an application. Vote 5 For, 2 abstain, Cllr Firth and Cllr Procter.

The costs are normally covered through fund raising events organised by members of the committee, but these events were not possible due to the restrictions imposed by the pandemic. The grant will cover marquee hire, toilet hire, signage, children's storyteller, adult storyteller and open mike publicity.
